MFI Grading Scale

The MFI Grading Scale at B2K is on an 8 point scale from B2K MF 1 to BWR MF8 with B2K MF 1 to be the highest grade while B2K MF 8 is the lowest grade. The MFI grades assigned referring to the ability of the MFI to manage its operations on a sustainable manner; they do not refer to the credit quality of the MFI and should not be used as a proxy for the creditworthiness of the company.

MFI Grading Process



The Grading process begins with request from MFI. The Business team will obtain Mandates in standard form from prospective client. B2K will assign a team of analysts and they will request for a list of information required from the MFI followed by management discussion. The team would then collate the information obtained and based on their analysis would submit recommendation to the grading committee.

The verdict of the committee for the assigned grading would be communicated to the management along with detailed copy of rationale for grading acceptance from the management. On acceptance BWR will disseminate the grading information on a wider basis through print, internet & other media. Apart from this, the MFI may use the Grading in their marketing literature. The initial g`rading will be valid for one year from the date of assignment. BWR will review the grading at the end of this period at the request of the MFI.
