BWR has principally relied upon the information/clarifications provided by the management.

The rating has positively factored the professionally qualified partners, their business experience, and favourable demand outlook for solar energy. The rating is, however, constrained by the firm being the new entrant in solar energy field as FY20 is the first year of its commercial operations and intense competition from organized and unorganized players in a highly fragmented nature of the industry.

#### **Background**

Arising Solar Energies LLP was established in May, 2019 with its office located at Bhopal, Madhya Pradesh. Mr. K Raj Kishan and Mr. K Sunil Rao are the partners of the firm. The firm has ventured into solar off-grid and on-grid segment as system integrator. It proposes to provide solutions and services in the field of renewable energy for installation of rooftop solar power projects with capacity upto 25-30 KW. The firm is targeting residential and commercial customers for rooftop systems. Currently, the firm has few on grid projects based on Photovoltaic technology.

## **Technical Capability**

### **Promoters Track Record:**

Mr. Raj Kishan is an electrical engineer with an overall experience of 2 years in solar energy field. He is also a NISE (National Institute of Solar Energy) certified solar roof-top grid-engineer. Mr. K Sunil Rao has an experience of 25 years in the field of construction (Real - Estate). He has been in the field of solar energy for the last six months.

# **Technical Expertise and Adequacy of Manpower:**

Mr. Raj Kishan is an electrical engineer, who is professionally qualified with NISE certification and involves in technical designing of solar project. The firm recruits additional technical staff on a need basis.

#### **Quality of Suppliers and Tie-ups:**

The concern deals with various suppliers located in Rajasthan, Gujarat and Madhya Pradesh and procures solar related materials like Inverter, PV Modules, ACDB, DCDB, AC & DC Wires, MC4, Connectors, Lighting Arrestors, Earthing Electrodes, GI Wire.

# **Customers and O&M Network:**

The target clientele are residential and commercial customers located in Madhya Pradesh. Currently, the firm is handling an ongoing on-grid solar project having capacity 2Kw. However, the



firm is in discussion for new projects.

The overall Technical Capability of the firm is considered **Weak** 

### **Financial Strength**

- The firm has not submitted any document to verify & confirm the contribution made as capital and hence unable to comment on the financial strength of the firm.
- As informed by the management, the firm is expecting revenue amounting to Rs. 0.10 Crs for FY20.
- The firm does not have any external borrowings as on date.

BWR hence, considers the Financial Strength of the concern to be **Poor**.
