

Grading Rationale 1st July 2025

B2K Analytics assigns "Solar Power (SP) Grading" for Decentralised Solar PV Applications" - System Integrator of "SP2C" to Ultraverse Infra Solutions Private Limited (the company). The Grading indicates 'High Technical Capability' and 'Moderate Financial Strength'.

System Integrator SP2C

B2K Analytics (B2K) has principally relied upon company's order book, publicly available information and information/ clarifications provided by the company.

The grading reflects the favourable demand outlook for solar energy, a debt-free capital structure, early project execution capability, and the company's focus on providing end-to-end EPC solutions across residential, commercial, industrial, and ground-mounted segments. The grading is also supported by the promoter group's experience, with group company engaged in a similar line of business for the past three years. Additionally, the business benefits from a good order pipeline, with the company already completing ~8 MW of solar projects and more projects currently under execution.

The grading is, however, constrained by the company's recent commencement of commercial operations within the last month which limits visibility into its operational capability. The absence of provisional financials, owing to the company's newness, and reliance solely on projections further restrict the assessment of its financial strength. Moreover, the company faces competition from other players with higher capabilities & with established name in the vicinity.

Ultraverse Infra Solutions Private Limited was incorporated on 14th January 2025. It is in Nirmohi Nagar, Jaipur, Rajasthan. The directors of the company are Mr. Ramakant Jangid, Ms. Priyanka Jangir, Ms. Ratna Shakya and Ms. Shivani Singh.

Ultraverse Infra Solutions Private Limited is an EPC contractor of Solar Power Plant based in Rajasthan. The company provides end-to-end solar services for domestic, commercial, industrial and ground mounted projects. The company's team of experts leverages cutting-edge technology to deliver efficient and sustainable energy systems.
